Subject: Continuance of recognition of MBBS degree granted by Pondicherry University, Pondicherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry - consideration of Assessment report - Reg.

Sir/Madam,

I am directed to inform that an assessment to assess the physical and the other teaching facilities available for continuance of recognition of MBBS degree (100 seats) granted by Pondicherry University, Pondicherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry was carried out by the Council's Assessors on 09th & 10th July, 2018. The said assessment report was considered by the Executive Committee at its meeting held on 07.08.2018 and it was decided as under:-

"The Executive Committee of the Council considered the assessment report (9th and 10th July, 2018) and decided to recommend that recognition of MBBS degree granted by Pondicherry University, Pondicherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry be continued restricting the number of admission to 100(One Hundred) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8(3) ...

- (2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 31.08.2018.

In case false/wrong declaration of fabricated documents have been used for procuring the approval of Continuation of recognition by the Council and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage, your

institution is liable not to be considered for approval of continuation of recognition with the annual intake capacity of 100 students and this approval is also liable to be revoked. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.
